From the Executive Director Julie Taylor

The National Farm Worker Ministry (NFWM) has undergone many changes in the last year. We have seen a transition in staff and are moving into 2020 with hope and vision. "Steps, next steps and future steps," this was the theme of the summer board meeting.

Farm workers also faced ongoing challenges last year. The boycotts continue against Wendy's and Reynolds (VUSE ecigarettes). These powerful companies continue to insist that they support their own self-monitoring but we know this is inadequate. Farm workers in their supply chains continue to experience exploitation. We have participated in pickets, marches, calls, petitions and a variety of other actions and will continue to join our farm worker partners in future opportunities.

Much of the organizing by our farm workers is done nationally as they seek consumer pressure for corporate influence and we are trying to leverage our member organizational influence by education and mobilization through social media and our website.

YAYAs were also in transition in 2019. The group was convened by Taylor Snider, a YAYA member herself, who worked to expand membership and presence for the group. YAYAs supported Farmworker Association efforts in Apopka, promoted CIW organizing in Florida and engaged in food justice opportunities. A sub-committee of the NFWM board has been and will be discussing future plans for the group and will be considering how we can best work to develop youth and young adult leadership in the farm worker movement nationwide.

For NFWM, we have refocused our efforts on education through the Harvest of Justice (last year's theme was farm workers and gender based violence).

NFWM Summer 2019 Board meeting

The summer meeting of the **National Farm Worker Ministry** (NFWM) board took place in Washington, DC specifically to learn and engage around farm worker legislation. Hosted by Church and Society of The United Methodist Church, the day on Capitol Hill began with presentations by Iris Figueroa and Adrienne DeVartanian of Farmworker Justice on the Agricultural Workers Program Act and H2A regulations. H2A visas in the US have grown exponentially in the last few years and ICE raids have created farm labor shortages around the country, creating strong demand for guest worker visas.

Kelly Bruner of Justice for Migrant Women, a new partner for NFWM in our gender based violence work, shared about the BE HEARD Act. This legislation would expand federal sexual harassment protections to businesses that employ less than 15 people, something especially important for small farming operations.

Justice for Migrant Women is the organization that promotes the Bandana Project, to raise awareness about gender based violence among farm worker women, now included in Harvest of Justice actions.

If you gave money, you most likely received a thank you note she wrote. If you attended a board meeting or other major event, you most likely were met first by her. If you read the e-news or newsletter, she was the primary writer. If you needed resources, she created many of them and provided much of the content on our website.

In recent years, Susan was the key staff person for the Boycott of Sakuma and Driscoll's berries with Familias Unidas that was settled in 2016, She was also the primary staff person in relation to FLOC and their tobacco campaign and was an integral part of supporting

the Triangle Friends of Farmworkers in NC. And, since the office moved to North Carolina, Susan shaped the lives of our interns as their mentor/coordinator. At this time Susan has determined that she will move on and explore new opportunities to help make a difference in our world. We wish her well in her next endeavor and will miss her.

We also said goodbye and a big thank you to Alexandria (Alex) Jonas, who took a position as Development Manager at WISER International. Alex has been a big part of NFWM since 2007, even during her threeyear hiatus to work at Fund

for Democratic Communities. She started as a Young Adult Mission Intern from the United Methodist Church and quickly became the NC Organizer and later was the Director of Development.

From the beginning, Alex was motivated by her passion for social justice and the farm worker movement: "I continue to be amazed by the farm workers and their supporters who are among some of the most inspiring justice seekers I've ever known."

She was instrumental in developing NFWM's new logo, website, digital and print communication and fundraising materials. Her accomplishments include developing our house party and sustainer programs. And we were especially blessed by her skills as a photographer.

FLOC: The latest!



FLOC staff in North Carolina and volunteers (including the Triangle Friends of Farmworkers) have been working together to stand with farm workers facing intimidation, abuse and wage theft. In the fall they dealt with a corrupt farm labor contractor impacting six farms in Eastern Carolina. Delegations of farm workers, union organizers and volunteers delivered letters to growers. At one of the farms, organizers were arrested as they tried to inform other workers of the wage theft and the union's willingness to support them. FLOC is continuing to address this.



On Friday, October 25th, FLOC's NC organizers went to leaflet Greanleaf workers about their rights, including domestic workers who confirmed they were not being paid the \$12.25 per hour that they are supposed to receive. The FLOC organizers were arrested and charged with 2nd degree trespassing.
